He was appointed by the governor in 1991 to serve on the original work group responsible for providing recommendations on the administrative structure for the State of Florida Department of Elder Affairs. The Council on Aging has experienced significant growth under his guidance. The agency offers home and community-based services to the older population of Escambia and Santa Rosa Counties. They administer many programs such as case management, senior companions, Meals on Wheels, and two rural senior centers plus many other programs. They also offer a caregiver support program to assist people who are caring for a loved one. All of these services are provided to give support to seniors and to encourage them to interact and socialize with other people. The Council on Aging of West Florida is compliant with the Better Business Bureau's Wise Giving Alliance Standards for Charity Accountability.

President Betty thanked our speaker and the volunteers and adjourned the meeting.
