WEEK IN REVIEW 08/18/2020

President Sally welcomed a gathering of the Pensacola Rotary Club members for the August 18th meeting. After the 4 Way Test, president Sally reminded everyone of the REEFS goal and had a funny voting joke! She quickly handed it over to Program Chair Chris Kelly to introduce today's speaker Jimmy Patronis – Florida Chief Financial Officer:

BIO - Jimmy Patronis is a native Floridian born and raised in Panama City. He earned his associate degree in restaurant management from Gulf Coast Community College and a bachelor's degree in political science from Florida State University. He is a partner in a family-owned seafood restaurant called Captain Anderson's that celebrated its 50th anniversary in 2017. His public service career began with experience as an intern in the Florida Senate and the United Kingdom's House of Commons. Following Patronis' college graduation, Governor Lawton Chiles appointed him to the Florida Elections Commission, and he was later reappointed by Governor Jeb Bush. He served in the Florida House of Representatives from 2006 to 2014, representing his hometown region in the Florida Panhandle. He was appointed to serve on Florida's Public Service Commission, as well as the Constitution Revision Commission, which meets once every twenty years to propose changes to the state constitution. He and wife Katie are proud parents to two sons, Jimmy Theo III and John Michael. Per website.

CFO Jimmy Patronis started by mentioning he had Jennifer Bobo on the zoom meeting and what a great help she is. The CFO then mentioned that Florida has been hit hard by the loss of sales tax from Covid. He mentioned how the gulf/beach areas have really helped pick up the tourism compared to central Florida. The CFO stated the State has Cares Act money earning interest but needs to manage it correctly to help plug the nonbudgeted Covid expenses and Covid liabilities. CFO Jimmy Patronis stressed that we need to press forward to help our small businesses and make sure the people coming to our State are safe. Last he mentioned the State websites that you should go to

fltreasurerhut.gov to get your owed money back

fraudfreefl.com to report fraud.

He then took questions:

Restaurant Industry with Covid – The CFO stated restaurants need to change to expand the capacity (hours, space, to go orders, to go alcohol) in order to serve as many customers they can to survive this stressful time.

Easing up on Restaurants serving alcohol vs bars serving food – Mr. Patronis advocated that when you have bars/lounges trying to operate we should try to make it as easy and flexible for them to bring in a food component to serve same customer
