WEEK IN REVIEW

MINUTES

Warm weather and warm smiles of Charles and Richard Sherrill greeted arrivals as Ted Brown sold Gene Killinger the \$61 winning raffle ticket. President Alan called the meeting to order with Betty Gail Peters leading us in prayer and the pledge. Alan went on to recognize President Ed Meadows of Pensacola State College for ranking 9th in the country in awarded AA degrees and President Judy Bense of the University of West Florida for her efforts with their football interest. Judy was also recognized for being newly elected to the University President's Council for Division II Athletics. And following, our Rotary Rooters gave us an appropriate serenade of patriotic songs.

President Alan surprised our Sunshine presenter, Scott Grissett, with the presentation of the Paul Harris Fellowship award. Not usually short for words, Scott went on to introduce our two military guest officers representing the United States Navy, visitors and visiting Rotarians. Birthday greetings were then sung to those celebrating this week.

David Stafford introduced our speaker, U.S. Congressional Representative Jeff

Miller. Rep. Miller has served the First District of Florida since 2001. He is appointed to serve on the House Armed Services Committee, Veterans Affairs Committee and the Select Steering Committee. The recent decision to raise the national debt limit he voted in favor of was very hard, especially considering the Federal Government issues 80-million checks each month and spending needs to be prioritized. Social Security, Medicare and the military use up all available funds each month and we must borrow for the balance. Those other areas of spending must be looked at to reduce spending as well as looking to all programs for future reductions. A new committee equally represented by Democrats and Republicans was created and must present \$1.4 trillion in spending cuts or across the board cuts will be made in discretionary spending. Both sides agree that the current glide path is un-sustainable and we cannot raise enough taxes for the current spending. Currently 51% pay no taxes. But we must cut spending. Social Security and Medicare are broke. The retirement age needs to be raised.

On military issues, we do not need to go into Libya. We are drawing down Iraq but it may be a mistake to announce a set date for the Afganistan withdrawals. Also, Pakistan harbors forces and supplies for terrorist that help continue the war there. We need to address those border safe harbors. We are going to get out of Afghanistan.

Answering questions, Rep. Miller stated we need a balanced budget amendment which nearly passed in 1995. Washington is ineffective and more needs to be shifted to the private sector. A consumption or flat tax is better than the present taxation. Medical cost are too high and drivers of much of the expense in federal programs. Tort reform would help reduce defensive medicine practices that help drive up cost. Escambia and Santa Rose Counties ask for assistance with title transfer to island residents to allow for a fee simple option in view of the new taxation on improvements on that land. With that, meeting adjourned.
