WEEK IN REVIEW

The weekly meeting of the Rotary Club of Pensacola was held at New World Landing on Tuesday, August 7, 2012. Members and Guests were greeted at the door by Tom Owens and Robert Palmer. Julie Tippins Parker and Bruce Partington teamed up for ticket sales. The lucky winner received \$53 and there were several winners of tickets to this week's Blue Wahoos games. President Innes Richards called the meeting to order and led us in the four way test. The first order of business was the reading by John Appleyard of a Resolution honoring the life and works of honorary member Dr. W. Clifton Payne, a Physician and Educator who lived and worked in Pensacola and Louisiana and distinguished himself with a life of service in the medical field and his dedication to Rotary. Dr. Payne, son of Rotarian Dr. Walter Payne, served as the 1972-73 President of the Rotary Club of Pensacola, and he is the father of active member L. Clif Payne.

Jay Windham from Sub-West Rotary announced that there will be a "Bowl Fest" on Friday, August 17 at Cordova Lanes and he was here to issue a challenge. The proceeds from the event will support the Rotary Foundation. Rotary Clubs may contribute by forming a team to compete or by purchasing a sign to advertise at the

event for a contribution of \$100. President Innes reminded members to sign up for committee service this week. Earl Hutto inspired us with the Prayer and Pledge. Father Jack Gray provided some Sunshine and recognized the guests of Rotarians and visiting Rotarians. Mark Harden, Bob Rogers and Charles Gund were present to receive Birthday greetings.

Scott Grissett introduced Don Pittman, Rotarian and Attorney from Enterprise, Alabama who provided an interesting history of the life of Paul Harris, Founder of Rotary International. Don hails from a family of Rotarians, men and women, who have served as leaders within their Rotary Clubs in Alabama and have been recognized at the state level for their service as Rotarians. Don became a student of Paul Harris and the founding of Rotary when he came upon an edition of the Autobiography of Paul Harris written in 1927 and published in 1928 that belonged to his father. In his research, Don found that two autobiographies had been written, the second edition was published in 1948. The first had been written during the time of serious illness when no one expected Paul Harris to survive. Paul Harris, the Founder and Father of Rotary International was born in Racine, Wisconsin in 1868, travelled and worked odd jobs throughout the United States after receiving his college

education from Princeton. He eventually settled in Chicago and lived until 1947. Paul Harris who was an attorney in Chicago in 1905 at the time he founded the first Rotary Club received his law degree from the University of Iowa, was raised as an only child by his elderly grandparents in the small town of Wallingford, Vermont. In 1907 the aspect of service was incorporated into Rotary and Rotary became the model for all other service organizations. In 1910 Canada created its first Rotary Club and Rotary International was born and Paul Harris left the work of overseeing Rotary International to the first Director, Chesley Perry and concentrated on his law practice. In 1926, Paul Harris was forced to retire from a very successful practice for health reasons and after recovering spent the last 20 years of his life as an ambassador for Rotary International which had become a worldwide success. President Innes thanked all who served and the meeting was adjourned.
