WEEK IN REVIEW

Al Stubblefield was flying solo as greeter on the beautiful VFR day with ticket sales being accounted for by Mort O'Sullivan and audited by Tim Kane. The meeting was called to order by President Innes leading us in The Four Way Test. Robert Mills led the Club in prayer and pledge to our flag. An announcement was made for the Family of Rotary event to be held November 15 and Maritime Park. Also, contribution forms for Rotary Foundation and "Every Rotarian Every Year" are being email to members for our timely reply. Cliff Payne's committee will be looking for all volunteers for the November 30th Habitat for Humanity home building project and Farage request input for the Club's list of community projects. Additionally, she ask for student applicants for the April 11th, 2012 Rotary Youth Leadership Award.

After a resolving scheduling issues due to performance demand the Club welcomed our very own "Rotary Rooters" who wowed us with their musical celebration of Christopher Columbus' landing in the new world. Following, Frank Beall presented some political humor and introduced our visitors, visiting Rotarians and led the group in birthday greetings to this week's celebrant. Our program was introduced by Tony Basel.

Members David Stafford and Alan bookman presented us with a timely overview of the upcoming election and the twelve constitutional amendments on the ballot this year. As Supervisor of Elections for Escambia County, David visited changes we have seen in voting methods from the first voting taking place after

General Andrew Jackson took over this new territory to our current state of the art voting equipment. More voters are voting early and by absentee ballot. Republicans outnumber Democrats but "no party" registration is up primarily by younger voters. With the latest census, Florida has gained two electoral votes and is now tied with New York for 3rd with California first and Texas in second in number. This year's ballot is loaded with many offices besides the President to be voted on.

Alan Bookman went over the constitutional amendments. He suggests we become informed prior to going to the polls otherwise you will never understand what is being presented.

- 1. Opts Florida out of Obama Care, basically symbolic as Federal law trumps Florida law.
- Extends homestead property discount to vets if disability was acquired when no a FL resident but they now live in the State.
- 3. Replaces the existing state revenue limit based on FL personal income growth with a new limitation based on population and inflation change. Some excess funds could support education or be returned to taxpayers. May hurt local government funding. Helps reduce big government.
- 4. Reduces from 10% to 5% the maximum annual increase in assessed value on certain non-homesteaded properties. First time home buyers (have not owned a home in FL in prior 3-years) get a 50% of the value of the home up to \$150,000 exemption, phased out over 5-years. Also helps non-homesteaded

- property where the market value reduces.
- May cut into separation of powers between the legislature and the judicial branch but having the Senate confirm Supreme Court Appointees.
- Prohibits public funding of abortion except for special conditions as rape, physical threat to the mother's life and other hardship cases.
- 7. This has been removed and is now under amendment 8.
- Repeals taxpayer funding for religious organizations.
- Homestead tax exemption for surviving spouse of vets who died from service related cause and also included first responder's spouses.
- 10. Provides additional tangible tax exemption on values between \$25,000 and \$50,000.
- 11. Allows seniors and low income homeowners additional homestead tax relief for values under \$250,000 with ownership for at least 25 years and are over 65 with a low income as defined by law.
- 12. Replaces the process for appointment of University student body president to the Board of Governors of the State University System.

Please read up on these amendments and the positions of all of our public officials running for office this November 6th. Get out and vote! Meeting adjourned.
