The Combined Rotary Clubs of Pensacola Twelfth Annual Ethics in Business Awards Luncheon was held under sunny spring skies at New World Landing on May 5, 2014.

Thanks to well coordinated efforts among the area's Rotary Clubs and the cooperation of the New World Landing staff, attendees at the meeting moved quickly through the doors and the buffet line. The room quickly filled with members of the local Rotary Clubs ready to honor the distinguished Ethics in Business awards. The awards are given in 2 categories – one for leaders of companies with less than 50 employees and the other for leaders of companies with over 50 employees.

The meeting was called to order by District Governor Ted Kirchaar who proceeded to welcome all guests and recognized all past District Governors, elected officials and past award winners. David Stafford was then called to the podium to lead the group in the invocation. Keith White then led the group in the pledge of allegiance and Jeremy Evans led the Four Way Test.

Ted Kirchaar and Ed Ranelli then introduced the 2013 award winners. Ron Gilette was the 2013 winner for small employers. Rone spoke to the importance of ethics, character and honesty as the cornerstones of success in life and in business. Ron then quoted Mark

After thanking all who made the meeting a success, President Stafford adjourned the meeting.
