#### WEEK IN REVIEW

On a particularly cold and gloomy day, members arriving for our weekly meeting received a warm greeting from David Stafford and William Stafford. Immediately inside, Jim Stolhanske and Mike Steltenkamp offered raffle tickets for sale. At the appropriate time, President John Shaffer opened the meeting and led the members in the Four Way Test. Earl Hutto delivered the prayer and pledge. Madison Currin provided a little Sunshine and introduced guests of club members, visiting Rotarians, and military guests.

Announcements preceded the day's program. Innes Richards informed the club that the last RLI workshop of this year will be held on February 28, 2015. Those interested in participating should contact Rotarian Innes. After Innes left the stage, the club was introduced to our newest member, Bob Scott, who recently relocated from Hawaii. He's been a Rotarian since 1998.

Club member Jerry Maygarden provided the day's program, which concerned the Greater Pensacola Chamber of Commerce. More specifically, the program explained the impetus and details of recent changes at the Chamber, discussed some of the Chamber's recent accomplishments, and identified the Chambers goals and objectives.

In the summer of 2013, State Attorney Bill Eddins determined that the Chamber is subject to the Florida's Sunshine Law. According to our speaker, the Chamber faced a choice: remain in the sunshine and comply with the sometimes onerous requirements of the Sunshine law or stop accepting taxpayer money. The Chamber chose to stop taking the money. To accomplish that task, Visit Pensacola and the Community Development Association - improvement of the local tourist industry is the goal of the former, economic development is the mission of the latter - were spun off from the Chamber. Now, those bodies perform the various functions associated with their stated objectives, including the receipt and administration of public money. By divesting itself of those functions and public funds, the Chamber is free to operate outside of the sunshine where it can be more effective. In addition, the Chamber empowered its Foundation to manage philanthropic and private gifts to the Chamber and attempt to determine whether members of the Chamber and the general public are satisfied with the Chamber's performance.

Rotarian Jerry mentioned various successes that have taken place in the past

few years. Many of which are due, at least in part, to the Chamber. Among other things, Rotarian Jerry cited an approximately four percent decline in area unemployment, the creation of over eight thousand new jobs and the retention of almost eight hundred more, increased tourism and local high school graduation rates, and increased Chamber membership. Additionally, while the ranks of the Chamber's membership have swelled, its payroll has decreased as a result of the streamlining allowed by recent changes.

Before concluding, Rotarian touched upon the current goals of the Chamber, which include small business development, leadership development, public advocacy on behalf of small businesses, and efforts to retain local military installations. He listed several present Chamber programs that seek to further these goals, including partnerships with PSC and UWF and the Leadership Pensacola program.

Following the presentation of the day's program, President John adjourned the meeting.
