Robert Mills delivered the prayer and pledge, and Jimmy Jones entertained us with his Sunshine Report. No military guests were present, and there were no announcements.

Our speaker for the day was Sara Hunile with the Pensacola Humane Society. She was introduced by Jerry Kindle. The Pensacola Humane Society is a non-profit, no kill organization that was established in 1943. The Pensacola Humane Society is committed to

improving the lives of companion animals in our community through advocacy, adoption, education and sanctuary. The humane society also strives to eliminate the need to euthanize healthy, adoptable animals primarily through a strong, aggressive adoption program.

The humane society's cases involve abandonment, families moving, natural disasters, marriage, divorce, finances, and unwanted litters. The Pensacola Humane Society takes care of 75-100 animals at any given time. They average around 30 cats and 30 dogs at the shelter. The average stay of an animal is 30 days. Their caring and devoted staff helped 900 animals in 2014. The Pensacola Humane Society will be opening a clinic this spring that will spay and neuter animals affordably. The

Pensacola Humane Society is always striving to improve their facility where animals are kept.

The Pensacola Humane Society funds its operations through private donations and fundraising activities. With no city, state, or federal government funding, they are reliant on the community to help with their mission. Their annual budget is \$500,000. The Pensacola Humane Society coordinates many events and activities that include Barktoberfest, Pilot for Paws, baby kitten showers, foster program, and a pet therapy program.
